The Triangle Chapter met for July on the first day of the month, at El Rodeo in Raleigh as usual. The pre-dinner conversation was almost all about the PDX/Carolina Cup/Restricted Regional at Rockingham the previous weekend. All the participants had a good time, but man, was it hot! Rex Deffenbaugh allowed that even though he had grown up in North Carolina heat and humidity that he was still unsteady getting out of the race car on Sunday and nearly passed out. Glad you didn't Rex! And I'll bet that if an equipment vendor selling cool suits had been there he would have made some easy sales. Our collective hats were off to Bruce Dover and his daughter Jennifer, for they worked the uncovered start stand without the benefit of an EZ-Up like we had on the turns. Thanks a lot, you two!

The one topic of conversation that wasn't about the PDX was what's now referred to as Mark Senior's alien life form video. Faithful readers of this column will recall that a couple months back, Mark, who is a civil engineer for the City of Raleigh, brought in a video of this odd (and huge!) colony of tubifex worms growing in a municipal sewer line. Taken with a remote camera, the colony is seen to pulse and move as if it were some giant brown blob right out of a sci-fi movie from the fifties. Well, Mark didn't do it, but someone posted that video to YouTube and on the day of the meeting it was the most watched video on that sight with tens of thousands of viewings. The news media then picked up on it and Mark had to write a press release to put an end to all the wild speculation. Way to go, Mark! Was that your 15 minutes of fame?

In the business portion, we talked about the drop in membership since this time last year, from 866 to 794, or about 9 per cent. Financially, it was noted that all programs were in the black as of June first and that overall we were about 8 per cent below our projected budget. The bad news was that we were heading to Rockingham, where we had trouble making money last year, and the low turn out for the restricted Regional that we had just experienced this year likely means a substantial loss for that event. I guess those NASA guys just didn't want to challenge us at the Rock. That's too bad because if we took another beating financially, then it is unlikely that we will ever race there again. We'll just have to wait for the numbers.

With regard to racing news, it was noted that the National Court of Appeals had overturned the findings of the SOM with regard to scoring the March Carolina Cup race on appeal from Estus White. You can read the decision in Fast Track on the SCCA website if you like, but most of us were just relieved that it was finally settled and over. But the bigger news was that the Region Board of Directors was very unhappy that the SOM at the Double National race had not penalized the two drivers who got into a fistfight at impound. The BoD intends to send a strong message that such conduct will not be tolerated at our events at VIR and voted to use the power granted to them under GCR 4.7.1 to refuse any entry at their discretion. The two drivers involved, who will not be named here, will be sent a letter telling them that their entries will be excluded for the next year, which means they will have sit out next year's Double at VIR. This will undoubtedly be a topic of conversation at the upcoming SEDIV mid-year meeting on July 25th.

We closed the meeting with a sort of round-robin speak-up if you have something to say. Mark Senior noted he still has a championship-winning ITC Honda for sale. My son Brian Shanks who was attending his first meeting told everyone that the PDX was awesome and that he was grateful for having been a part of it. He even enjoyed his first experience being on the corners for the races. And we learned that Boz Marchi's F500 which had an unfortunate encounter with the pit wall after a spin in 17 at VIR was finally mended, but that it was all in pieces and now needed to be reassembled like a big mechanical jigsaw puzzle. Have fun with that Boz! Hope you make it in time for the Goblins Go!

And why don't you all make it out to the next Triangle Chapter meeting on Wednesday, August 5th? Come and chill out with us on what will undoubtedly be a warm August night and find out what all your friends have been up to since our last event. I'll see you there . . . or at the races!

NCR Board Meeting Summary, May 20, 2009

Present: James Shanks, Heather Powers, Assistant R.E., Buddy Matthews, John Uftring, Steve Keadle, Joedy Pennington representing Ed Wentz, the West Chapter Coordinator, Blair Stitt, John Lindquist, Ron Gentry, Wayne Quick, Steve Rose, Bruce Dover, Ginny Condrey and Jerry Pell.

1. The meeting was called to order by Heather Powers, Assistant R.E., at 7:45p.m. at Overtime Bar and Grill, Exit 153, I-40/85, Mebane, NC.

2. Motion (Stitt/Pennington) to approve the Minutes of the April 15, 2009, BoD meeting; Passed.

FINANCIAL REPORTS

1. Treasurer's Report: Steve Keadle, Treasurer, reported as to the Region's cash on hand and that based on the P&L vs. Actual report the Region is under budget (to the good) through April, even after considering those line items which are over budget. Net income through April, 2009, was in the black and that through April each race event in 2009 was also in the black. A copy of the Profit & Loss vs. Actual, through April (3 page report) is attached to these Minutes, as is a copy of the Profit & Loss by Class, (3 page report).

The IRS Code section, 501(c) (4)-Civic Leagues and Social Welfare Organizations, commonly referred to as not for profit organizations' rules regarding tax exemption are attached to these Minutes. The Treasurer recommended that any rental rate charged by the Region for use of its equipment and/or services be at fair market value rates. Further, any contributions to the NC Region, SCCA, is NOT a tax deductible contribution, thus contributions to the Region's Worker's Fund would not be tax deductible.

A fee will be paid to the Region from the Trans Am event held at VIR in April, and the Region will receive a fee from the Formula SAE event, held at VIR. From these fees certain related expenses must be deducted, such as worker credits, etc.

OLD BUSINESS

1. The protest arising from the CCPS race held during the March Memories event at VIR, in 2009, has been heard and decided in favor of the protest filed by Estes White.

NEW BUSINESS

1. Meeting Location: Motion (Matthews/ Pennington) that next month's BoD meeting location be at Overtime Bar and Grill, Exit 153, I-40/85, Mebane, NC; Passed.

REPORTS

1. Chapters:

A. Triangle Chapter: James Shanks, Triangle Chapter Coordinator, reported that 26 members attended their last Chapter meeting wherein some of the matters discussed at the last NCR BoD meeting were reviewed. The Chapter welcomed a new member to its fold.

B. West Chapter: John Lindquist reported that about 13 members attended the last West Chapter meeting and he summarized the content of the West Chapter meeting, which included a review of some of the business conducted at the previous NCR BoD meeting.

C. Cape Fear Chapter: No Reports.

2. Committees:

A. The Competition Board held a debriefing after the Double National races at VIR in April. Certain issues were discussed with reference to the Double National event. The Region received kudos from the Trans Am group and the National tech. representative, from the SCCA, with reference to our Double National event. The next meeting of the Competition Board is scheduled for May 21, 2009.

The EV Chief for the Region is now Tim Gardner. The EV team, going forward, will also include the former EV Chief and Pete Papas.

The Chairman of the Competition Board reported on issues regarding some actions taken at the Region's recent

Double National event in April, and of the requests made of Rick Mitchell, the SEDIV Executive Steward, as to same, which requests will be considered in due course.

Ron Gentry discussed some problems which arose with some Spec. Miata drivers at the Double National event, having to do with an altercation, in impound, following a Spec. Miata National race. This matter will be further considered by the BoD at a future meeting.

Blair Stitt discussed the call to the grid after lunch on Sunday at the Double National in April, in connection with an alleged quick 5 minute call.

James Shanks advised of an issue regarding awarding trophies for the Double SARRC/MARRS event – he advises that only 3 trophies were given out in each Class, as opposed to the top 3 in SARRC and the top 3 in MARRS, in each class.

The Supplemental Regulations for the Double SARRC/MARRS race event had limitations on the trophies to be awarded per group/class, but that the BoD's action to expand the eligibility for trophies, to be awarded, came after the Supps. for this event were published.

The Treasurer reports that the cost of trophies for May's event has not been determined, as our accounting procedures allow 60 days after each event to turn in bills for payment.

Ron Gentry discussed certain concerns voiced regarding Spec. Racers, and Production cars, being in the same race group; in particular some Spec. Racers from the WDC Region do not like being grouped with Production cars. Ron advises that he is passing on these comments to the Safety Stewards.

Heather Powers reported that she received some comments from some of the members that the Trans Am race results were not in our Newsletter nor was there an article on the outcome of the race. The Trans Am event was held at VIR in April as part of the Region's Double National event.

James Shanks reviewed with the Board an email he received from Mark Senior in reference to putting the PDX registration information on the Region's website, to allow early registration, i.e. before June; it was reported that registration will open in late May for the PDX/Regional race, scheduled for Rockingham. The Board discussed the Region's PDX program's future use of the Rockingham race facility, for PDX events and some other road course race events, to be put on by our Region.

The process to open registration for the PDX event is almost complete, and will be online shortly.

John Lindquist, Heather Powers and others will attend the Triad Sports Car Club's event on the 21st of June, a car show and autocross event at Grove Stadium in Winston-Salem wherein information as to the Region's PDX event at Rockingham will be made available. Presently there are 28 pre-registered entries for the PDX event and about 10 instructors have pre-registered for that event.

The Honda S-2000 roll bar issue was discussed. The S-2000 with a hard top is ok for a PDX, but there is an issue as to the fact that the factory roll bar is not above the height of the seat back, and, thus, is not apparently sufficient. Buddy Matthews will look further at the PDX Rules as to this issue.

Membership: No report, except James Shanks requested we obtain an email address for the new "weekend" memberships.

Publicity: John Uftring reports that the ad for the Region's PDX event in June, at Rockingham, is presently in the current edition of Grassroots Motorsports; further, there will be advertisements later for our Region's Races, this fall at VIR. John further discussed the availability of a new NCR-SCCA brochure, for distribution at car shows and other such events.

Charities: Blair Still reports that approximately \$1,600.00 was raised by the NCR at the Double National event in April for the Ronald McDonald House charity, and that approximately \$1,200.00 was raised by th NCR for the Angels Among Us charity at the Region's Double SARRC/MARRS event, at VIR, in May.

Motion to adjourn (Pell/Shanks); Passed

NCR Board Meeting Summary, June 24, 2009

1. The meeting was called to order by Glenn Long, R.E., at 7:40 p.m. at La Cocina Restaurant, at Exit 153, I-40/85, Mebane NC, as the Overtime Bar and Grill location was not available.

2. No minutes were presented from the last meeting due to the Secretary's absence.

FINANCIAL REPORTS

1. Treasurer's Report: Steve Keadle, Treasurer, reported that YTD expenses compared to actual budgeted amounts is in the positive. It was decided that the Region's Specialty Chiefs would receive a monthly financial sheet to track their actual expense items compared to budgeted items, so to permit them to monitor their line item budget responsibilities.

OLD BUSINESS

1. Meeting Location: The Board's meeting location will be at La Cocina Restaurant in July.

2. Rockingham: The Board discussed the Rockingham contract for the Region's September PDX event. The Board is still looking at whether it will operate the event in September, and it will make its decision partly based upon the results of the PDX event to be held on the weekend of June 27, 2009, at Rockingham.

NEW BUSINESS

1. James Shanks discussed the positive results from our Double SARRC/MARRS event held at VIR, wherein there was a very good turnout of volunteers from the WDC Region, which workers helped to make this event a big success.

Scales: It was reported that there will not be scales available for the Regional event to be held on June 28th, at Rockingham.

2. Sanctioning SCCA Members. The Board had a very lengthy discussion of driver conduct at the Region's recent Double National event, and at some of our Region's other events. After a substantial amount of discussion and heated exchange of ideas and positions, the Board's consensus is that intentional reckless driving (running into another competitor) is not acceptable conduct at our Region's events. The Board expressed its general opinion that it expected to see the SOM, from the race event at issue, to handle these types of on track and altercation issues, at the track. The SOM are licensed officials authorized to review conduct, issue decisions and enforce the penalties imposed on sanctioned drivers. A motion was made that the Board vote as to each of the three drivers who were involved in unacceptable conduct (altercations) at the Double National race event, held at VIR in April, and that the BoD should take appropriate action. A motion was made and passed to vote on each driver, individually, with reference to whether the Board would take any disciplinary action with respect to any or all of the three drivers. Motion (Gentry/Keadle), Passed unanimously, to take some form of disciplinary action on an individual basis for each of the three drivers. James Shanks stated his opinion that the Board should send a letter stating that the behavior of the type described is unacceptable to the Region and would not be tolerated in the future at the Region's VIR events, and that the Board believes that the SOM, of the event, should have taken care of these matters at the track.

As to Driver # ...869, Motion to take additional action, (1 – yea), (7 – no); the Board advises that it is in agreement with the actions taken by the SOM at the event with reference to Driver # ...869.

As to Driver #...781, Motion to not accept an entry from him for a period of one year from this date (June 24, 2009), Passed, (6 – yea), (2 – no).

As to Driver #...542, Motion to not accepted an entry from him for a period of one year from this date (June 24, 2009), Passed, (6 – yea), (2 – no).

The Board directed that a letter be sent to these two drivers stating that entries will not be accepted from them for NCR race events for a period of one year from this date (June 24, 2009), and that a copy of these two letters be sent to Rick Mitchell, Executive Steward, SEDiv.

REPORTS

1. Chapters:

A. Triangle Meeting: 20 members were in attendance, including one new club racing member.

B. West Chapter: 10 members were in attendance, the membership discussed the Triad's Sports Car Club Autocross and the West Chapter's involvement with the display of some of our race cars at this event on June 21, 2009.

2. Committees:

C. Membership: Currently there are 794 members in the NC Region, a reduction this year of 9%.

D. Publicity: John Uftring advised that he will be put a link for "Facebook" and "Twitter" on our website.

E. Registration: The Board discussed Motor Sports Registration handling registration for our race events and discussed the pros and cons of same. The Board decided to discuss this matter further at the July BoD meeting, after the Rockingham event is concluded, to determine how registration through Motor Sports Registration was handled for our PDX/Regional event at Rockingham on June 27-28, 2009.

F. Budget and Finance: The Committee has held a B&F meeting and will meet again in August.

G.
